CALL TO ORDER

Mayor Coleman called the meeting to order and determined a quorum. Present were Kevin Painter, Scottie Betts, Marc Murdaugh, and Sam Gilley.

OPENING CEREMONIES

- C. Mayor Coleman welcomed everyone in attendance.

APPROVAL OF MINUTES FROM REGULAR SCHEDULED MEETING September 11, 2023

Alderman Painter made motion to approve minutes of September 11, 2023 as written. Alderman Betts seconded the motion. Motion passed 4-0.

APPROVAL OF AGENDA for October 9, 2023

Alderman Betts made motion to approve agenda for October 9, 2023. Alderman Painter seconded the motion. Motion passed 4-0.

REPORTS

A. Parks and Recreation / Public Works-

Mike Hutcherson updated the board of the new trucks being in production and expected to be shipped soon. He discussed a need for some paving to be completed on the walking trail and asked to put the work out for bid and have the board review the received bid. Alderman Betts made motion to set a called

meeting to review the asphalt bid for walking trail when received. Alderman Painter seconded the motion. Motion passed 4-0.

Mike asked for consideration of hiring Jake McGehee full-time for parks & recreation. Kim noted that this would increase the existing budget by \$40,000. After discussion, Alderman Betts made motion to hire Jake McGehee full time. Alderman Murdaugh seconded the motion. Motion passed 4-0.

- B. Interim Fire Chief/Building Inspector- Matt Brown -absent
- C. Police Chief-

Jason Oliver reported 295 calls for service, 1561 camera tickets, 33 citations, and 7 arrests for the month of September. He noted he has one officer transfer from full-time to part-time, he has hired one new officer, he has 1 vacant position, and one deployed position on hold.

D. Recorder/Treasurer-

Kim Gilley reviewed accreditation received from the TN Comptroller's Office for a timely budget adoption. She noted to the board that they will find in their financial report that there was a transfer of funds for the general fund to the money market fund. She noted to the board that she had increased the Parks and Recreation budget by \$18,400 to cover the damages incurred to electric and water by the TN River Basin Project. She also increased the Police equipment budget by \$9400 to cover the additional billing for Body Cam/Car Camera project. She has for the board's approval to remove the Disaster Service's Personal Property taxes for the year of 2021 and 2022 and keep them on file so that the business cannot reopen in the City of Medina until these taxes are paid. They have moved out, no forwarding address, and unable to locate anyone associated with business. Alderman Painter made a motion to remove the tax from the books but remain on file. Alderman Betts seconded the motion. The motion passed 4-0.

CITIZENS INPUT

There were no comments or concerns.

SECOND READING OF AN ORDINANCE TO REZONE PROPERTY LOCATED AT 420
NORTH MAIN STREET FROM M-1 (INDUSTRIAL) AND R-1 (LOW DENSITY

ORDINANCE NO.

WHEREAS, Section 8(b) of the Medina Private Act Charter stipulates that the salaries of the Mayor and Aldermen shall be set by Ordinance, and further provides that the salaries of the Mayor or Aldermen shall not be changed during their terms of office; and

WHEREAS, the current term of the office of mayor shall expire at the first regularly scheduled meeting of the Board of Mayor and Aldermen following the November 5, 2024 municipal election.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF MEDINA HEREBY REPEALS CITY ORDINANCE 12-03 RELATING TO SETTING THE ANNUAL SALARY OF THE MAYOR AND REPLACES WITH AN ORDINANCE TO READ AS FOLLOWS:

- **1.** Annual Salary of the Mayor. The annual salary of the Mayor of Medina shall be \$74,000.00.
- 2. <u>Effective date</u>. This ordinance shall be in full force and effect from and after the administration of the oath of office to the person elected mayor in the municipal election of November 5, 2024 at the first regularly scheduled meeting of the Board of Mayor and Aldermen following said election.
- **3.** Repealer. All ordinances, and parts of ordinances, determined to be inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.
