### REPORTS

A. Parks and Recreation / Public Works-

Mike Hutcherson reviewed street department monthly maintenance work. All asphalt paving as been completed as per bid. Splashpad is now open for summer. Bids for tree removal at park has been received, they are sending out second round to get cost reduction, then contracts will follow, with a date set for work to begin. He stated he received word from truck dealer that the two trucks should be scheduled to hit the assembly line within next month.
