Mayor Betts called the Budget Public Hearing to order and asked for any comments or concerns relating to the 2025-2026 Fiscal Year Budget. There were no comments or concerns, therefore Mayor Betts closed the public hearing.

Public Input on the annexation, consented by property owners (City of Medina, Gibson County Special School District, and Gibson County Electric Membership Corporation), would incorporate properties located on Middle School Street, Hornet Drive, South Gibson High School Drive, and Mt. Zion Road into the municipal boundaries of Medina. Mayor Betts called the Public Hearing relating to annexation of South Gibson County High School Sports Complex, Medina Community Park, Gibson EMC property and Medina Elementary School property. There were no comments or concerns, therefore Mayor Betts closed the public hearing.

REGULARLY SCHEDULED BOARD MEETING BOARD OF MAYOR AND ALDERMEN CITY OF MEDINA, TENNESSEE Minutes Monday, June 2, 2025 6:05 PM

CALL TO ORDER

Mayor Betts called the meeting to order and determined a quorum. Present were Kevin Painter, Andrew Rhodes, Mayor Scottie Betts, Marc Murdaugh, and Angi Mathenia.

OPENING CEREMONIES

- A. Invocation was given by Andrew Rhodes
- B. Pledge of Allegiance was led by Kevin Painter.
- C. Mayor Betts welcomed everyone in attendance.

APPROVAL OF MINUTES FROM REGULAR SCHEDULED MEETING May 5, 2025

Alderman Painter made the motion to approve minutes of May 5, 2025 meeting. Alderman Murdaugh seconded the motion. Motion passed 5-0.

APPROVAL OF AGENDA FOR June 2, 2025

Alderman Murdaugh made the motion to approve agenda for June 2, 2025 meeting. Alderman Rhodes seconded the motion. Motion passed 4-0.

REPORTS

A. Parks and Recreation / Public Works-

Mike Hutcherson reported that playground/pickleball courts construction should begin next week. Completion of the park grant project is scheduled for September 16th. The front door at the Civic Center is scheduled to be replaced the week of June 23rd. The park fields are scheduled to be top-dressed on June 16. He noted the asphalt paving has been completed with Campbell and Blackmon being completed in July. He informed the board that he is replacing his tractor with monies from his current equipment budget. The amount of the purchase is \$27,000. He will be trading in the city's existing tractor that was damaged in the accident.

Discussion on JEA Ponds Property

Mayor Betts reviewed an opportunity to acquire the JEA ponds property (17.54 acres) as a donation from JEA. It would potentially provide fishing, walking and hiking trails. Prior to acceptance of this property, the ponds will need to have the water tested. He asked the board of their thoughts of pursuing this. Alderman Mathenia asked what the insurance cost would be. Mayor Betts stated an annual cost of \$500. After much discussion, the board voted 5-0 to continue the process of getting testing and cost analysis for this proposed project.

Discussion on utilization of Medina Lions Park was discussed. A drawing from City Engineers showed a layout for soccer fields utilizing all areas of the park for a soccer complex in the future. Alderman Painter asked about field dimensions. Alderman Mathenia asked about parking. Alderman Painter asked for this proposed drawing to be sent to the Parks and Recreation Board for their review and brought back to this board with their recommendation.

B. Fire Chief-

Mark Cleveland reported 25 calls for the month of May with 80% being medical calls. There was an average of 3.93 responders per incident.

C. Building Inspector –

Matt Brown reported 7 building permits, 6 plumbing, and 2 pool permits for the month of May. He issued 25 letters for property clean-up with 13 more issued on this date. He updated the board on potential areas for fuel stations and he reported that Clark Family commercial construction of 5- bay building is near completion. He discussed 38 Rae Cove legal issues and was urged to proceed with any actions that could be taken to rectify this issue.

D. Police Chief-

Phillip Kemper reported 32 citations, 9 arrests, 396 calls for service and just under 1100 camera violations issued for the month of May. He reported to the board that the 12th employee was hired as of this date which now has the department

fully staffed. He also noted that Chase Cummings will be back on June 20 from the academy. He noted the tasers and rifles are in, handguns will ship next week, Flock cameras are awaiting TDOT verification, and e-citations are scheduled to be in place by September 10th. He acknowledged Sgt Taylor and Ptl. Johnson for their professional apprehension of a suspect in the shooting on 105 Bobbitt Road and life-saving actions for a citizen in major distress.

E. Recorder/Treasurer-

Kim Gilley noted that July 4th fireworks will be on Thursday, July 3rd. City is pursuing food trucks for event. Budget will be forwarded to Comptroller upon 2rd reading approval of the board.
